Beloved Huzur aba stated; "...We should fulfil our pledge of allegiance (bai'at) by seeking nearness of Allah the Almighty...you should increase your knowledge, listen attentively to the words of the Promised Messiah a.s., carefully read and reflect upon his guidance and teachings...Only when both men and women increase their understanding of the faith can they reform their practical lives...If we fail to bring about spiritual, intellectual and moral reformation; if we do not treat others with kindness; if our morals are such that people become distressed or fearful because of our behavior, then such bai'at serves no purpose. Each of us should examine ourselves and ask whether our condition is such... he (The Promised Messiah a.s.) addressed those who had entered his bai'at, saying that they should become a people in whose company no one remains deprived of good fortune, whose morals are of the highest standard and who remain steadfast upon the moral quality taught by Allah the Almighty.
